THREE (3) YEAR LIMITED WARRANTY COVERAGE

- Warranty registration card and original receipt is required for warranty service
- All film products are to be used in compliance with all acceptable state or provincial laws. Installation of any product in a manner that violates these laws is a misuse of the product and VOIDS all warranty expressed, stated, written or implied. It is the vehicle owner's responsibility to insure the film installed is in full legal compliance to the state in which the vehicle is registered and tagged; otherwise, the warranty is invalid.
- The above warranty does not cover fading or any defects or damages other than those specified above and is made solely to the original purchaser and may not be transferred.

- If products specified above fail to conform to the warranty during the coverage period, purchaser may obtain replacement and installation of the product free of charge at any authorized LLumar/CPFilms installer anywhere in the United States or Canada.
 - The obligation of CPFilms under this warranty is limited to replacement of product not conforming to the warranty. Proof of purchase will be required by the authorized installer to substantiate valid warranty coverage.
